^{*}Article 35 of the Revised Copyright Act states that "a person in charge of teaching" and "a person taking classes" at "a school or other educational institution" are allowed to reproduce, publically transmit ("public transmission for the purpose of a class"), or publically convey a copyrighted work in "the course of those classes" without receiving prior consent or paying compensation. However, this does not apply if the event that the interests of the copyright owner would be unreasonably prejudiced.
