### 2. Application Eligibility

Individuals who satisfy one of the following requirements:

- (1) Individuals who have Master's degrees or Professional degrees, or those who are expected to earn one by March 31, 2022.
- (2) Individuals who have degrees equivalent to a Master's degree or a Professional degree abroad, or those who are expected to earn one by March 31, 2022.
- (3) Individuals who have completed courses offered by a school in foreign countries through correspondence courses while living in Japan and earned a degree equivalent to a Master's degree or a Professional degree, or those who are expected to earn one by March 31, 2022.
- (4) Individuals who have completed a program of a foreign educational institute located in Japan authorized by the school education system of relevant foreign countries as those having graduate school programs, and designated separately by the Minister of Education, Culture, Sports, Science and Technology, and who have earned a degree equivalent to a Master's degree or a Professional degree, or those who are expected to earn one by March 31, 2022.
- (5) Individuals who are designated by the Minister of Education, Culture, Sports, Science and Technology, under the provision of Paragraph 6, Article 156 of the Ruling on the Implementation of the School Education Law of Japan (Notification No. 118, Ministry of Education, 1989).

Individuals who have been engaged in research at universities, research institutes, etc. for two years or more after having satisfied any of the requirements listed below, and who are recognized by the University of Aizu Graduate School as possessing scholastic ability equivalent to or higher than that of those who have Master's degrees or Professional degrees, based upon the results, etc. of relevant research.

- a) Individuals who have graduated from universities described in Article 83 of the School Education Law of Japan
- b) Individuals who have completed sixteen years of school education outside Japan
- c) Individuals who have completed sixteen years of school education of foreign countries through correspondence courses while living in Japan provided by schools in the relevant countries

- (6) Individuals who will have reached the age of 24 as of March 31, 2022 and are recognized by the University of Aizu Graduate School as possessing scholastic ability equivalent to or higher than that of those who have Master's degrees or Professional degrees.

Notes

- 1: With regard to applicants for the AY 2022 Autumn Admission (**3223, 3224**), the date, "March 31, 2022," shall be read as "September 30, 2022."
- 2: An individual working may apply for and enroll in the Doctoral Program while holding a position in a government office or enterprise, etc.
- 3: **Prior to making an application, each applicant must obtain approval from the faculty member from whom the applicant wishes to have instruction and advice about his/her research plan, etc. during his/her enrollment in the Doctoral Program.**
- 4: Applicants who wish to apply for the Doctoral Program under (5) or (6) above, and **applicants from fields other than computer science and engineering (hereinafter referred to as the "Individuals from Other Fields")** are required to go through a preliminary examination regarding eligibility for application. Please read section "9. Preliminary Qualification Examinations" carefully, and submit necessary documents for the preliminary examination by the deadline.

### 3. Application Procedures

(1) Making the Applications

Application documents must be placed in an envelope, on which "Graduate School Application Forms Enclosed" must be written in red, and the applicant's name, address and ID number (applicable only to the students of the University of Aizu) must be indicated.

It must be submitted by the applicant in person or be mailed using Registered Express Mail or a traceable method such as EMS (from outside Japan) to the address given in (2) below.

(3) Application Deadlines

Applicants may apply for both the 1st and 2nd entrance examinations for spring or autumn admissions. However, applicants are required to take the application procedure for each of the entrance examinations separately.

Applicants shall not be allowed to apply both for the 2nd entrance examination for Spring Admission (**3222**) and the 1st entrance examination for Autumn Admission (**3223**) at the same time, for which the examination date is the same.

- (4) Should any false statement be found in the application documents, admission might be canceled even if the applicant's admission has been previously approved.
- (5) **An applicant falling under the conditional qualification (1), (2), (3) or (4), in "2. Application Eligibility" must submit a Certificate of Graduation at the time of admission. If the applicant becomes unable to fulfill the requirement, his/her admission will be canceled.**
- (6) Application documents and application fee will not be returned in the case the admission is canceled for the reason (4) or (5) above.

#### 5. Examination

- (1) Selection Method

Successful applicants shall be selected comprehensively through an oral examination (interview), and by examining application documents. In the case that an applicant residing outside Japan has difficulty in coming to Japan to take the oral examination, an interview may be conducted by Skype etc.

In the oral examination, each applicant shall be examined on his/her English proficiency, specialized knowledge of computer science and engineering, summary of previous research conducted (e.g., Master's thesis), and future research plans. Oral examinations shall be about 30 minutes per applicant. Obtain advice from your research advisors on how to give a research presentation. It is possible to prepare materials for the interview and distribute these materials to the examiners. Also, it is possible to use audio-visual aids for presentations, e.g. OHPs and PCs.

Note: Oral examinations for individuals who fall under the Application Qualification (5) or (6) and Individuals from Other Fields shall be about 45 minutes.

## 7. Admission Procedures

(1) Necessary Procedures

- a. The documents necessary for admission procedure will be sent to successful applicants by postal mail after the announcement of successful applicants.

- b. In principle, documents should be submitted by the applicant or proxy. Those who are residing outside Japan should ask a person residing in Japan to submit the documents on their behalf, or should mail them by a traceable method such as EMS.
- c. Incomplete documents will not be accepted.
- d. Once received, admission documents will not be returned under any circumstances.
- e. Once received, admission fees will not be returned under any circumstances.
- f. Should any individual fail to complete the admission procedure by the prescribed date, he/she shall be regarded as having declined enrollment in the University.

## 8. Other

### (1) Procedures for entering and residing in Japan

Necessary procedures for entering and residing in Japan must be completed by the time of admission to the University. Failure to obtain a student visa, etc. in time shall void the entire admission procedure. In that case, fees paid and documents submitted will not be returned. Completion of formalities and necessary procedures for entering and residing in Japan are the solo responsibilities of student's.

When applying for a student visa, some may be required to submit a "Letter of Admission". Please note that the "Letter of Admission" shall be issued to successful applicants only if they have completed the admission procedure and paid the admission fee. Each applicant is advised to get the information on the visa application procedures at the Japanese Embassy, etc. beforehand.

### (2) Scholarships

Applications can be made for a scholarship from the Japan Student Services Organization for Postgraduates, and other scholarships. Details of scholarships will be explained after entrance to the University.

### (3) RA System

The University offers RA (Research Assistant) positions to students of the Doctoral Program.

In FY2021, a maximum of 360 hours per student will be allocated at an hourly wage of 1,200 yen (depending on the number of student). In addition, if a student is selected for an outstanding student category (number of available slots: 10), 240 hours per student per year will be added. (The total amount including an outstanding student category will be a maximum of 720,000 yen.)

### (4) Living Expenses

Approximately 100,000 yen per month is necessary for living expenses, not including tuition.

### (5) Boarding Houses and Apartment Houses

Students must find accommodations on their own. Accommodation information is available at the University website.

## **Graduate School Admission Policy**

The University of Aizu is the first university in Japan solely dedicated to computer science and engineering. Computer science and engineering is a promising and cutting-edge discipline with a wide range of applications, and it is becoming a core for technology regarding knowledge production. True to its founding principles "Starting from Local Communities to the World" and "to Advance Knowledge for Humanity", the University of Aizu has always conducted cutting-edge research and comprehensive education in computer science and engineering with a faculty comprised of highly accomplished researchers from around the world.

The University of Aizu Graduate School was established in April 1997 as a place for pioneering academic research and education that contributes to a global society. The Graduate School aims to develop highly creative individuals by providing diverse courses that incorporate advice from the private sector within a superior educational and research environment. In order to develop the ability of students to solve problems in a global environment, classes are generally taught in English. The University of Aizu Graduate School has set forth the following expectations for qualities of incoming graduate students, and the following basic admission selection policy.

### **Expected Qualities of Graduate School Students**

#### [Master's Programs]

The Master's Programs seek individuals, from both within and outside Japan, who satisfy the following criteria:

- Have acquired basic computer science and engineering knowledge and skills at the University of Aizu, another university or an advanced course of colleges of technology, etc., despite possibly having majored in a field other than computer science and engineering.
- Wish to study advanced computer science and acquire engineering knowledge and skills, and possibly project development and management, to play an active role in industry as a researcher, engineer, or team leader.

#### [Doctoral Program]

The Doctoral Program seeks individuals, from both within and outside Japan, who satisfy the following criteria:

- Have sufficient capability and desire to conduct advanced computer science and engineering research, and expect to play a leading role as a scientist/educator in academia or as a researcher, planner, and/or promoter of new projects in industry.
- Possess a passionate curiosity, a spirit of taking on new challenges, and a strong desire to research and develop new knowledge for humanity and new systems that are useful to society.

### **Basic Admission Selection Policy**

The University of Aizu Graduate School shall conduct a document screening including research plan and oral examination in English to confirm the applicant's basic computer knowledge and the skills, English proficiency, motivation, and discipline needed to study advanced computer science and engineering. However, under certain circumstances, we may only review the application documents depending on examination category.
