Chapter One
General Provisions

Article One
(Purpose)

1.1 This regulation, based on the provisions of Article 13, Paragraph 2 and Article 23 of the Statutes of the Public University Corporation, the University of Aizu (hereinafter referred to as the “STATUTES”), provides for necessary matters concerning the organization and business operation of the Public University Corporation, the University of Aizu (hereinafter referred to as the “CORPORATION”), and the University of Aizu and the University of Aizu Junior College Division (hereinafter referred to as the “UNIVERSITY”) established by the CORPORATION.

Chapter Two
Organization

Article Two
(Internal Organizations of the Corporation)

2.1 Besides the UNIVERSITY established in accordance with Article 3 of the STATUTES, Evaluation Office, Audit Office and Office for the Compliance Promotion shall be established within the CORPORATION. The delegated duties of internal organizations of the CORPORATION (other than the UNIVERSITY for the purpose of this Article, likewise hereinafter.) shall be as provided for in the table below.

2.2 Necessary matters concerning internal organizations of the CORPORATION shall be provided for separately.

Article Three

(The Undergraduate School)

3.1 School of Computer Science and Engineering shall be placed within the University of Aizu.

3.2 Necessary matters concerning the School of Computer Science and Engineering and the University of Aizu Junior College Division shall be in accordance with the provisions of the Ruling on the University of Aizu and the Ruling on the University of Aizu Junior College Division respectively.

Article Four

(The Graduate School)

4.1 The Graduate School shall be placed within the University of Aizu.

4.2 The Graduate School of Computer Science and Engineering shall be placed within the Graduate School provided for in Paragraph 4.1 above.

4.3 Necessary matters concerning the Graduate School shall be in accordance with the provisions of the Ruling on the University of Aizu Graduate School.

Article Four-Two

(The Center for Planning and Promotion)

4-2.1 The Center for Planning and Promotion shall be placed within the University of Aizu.

4-2.2 Necessary matters concerning the Center for Planning and Promotion shall be provided for separately.

Article Five

(The Administrative Office, Etc.)

5.1 Administrative Office shall be established within the UNIVERSITY to deal with administrative matters concerning general affairs and planning, accounting, facilities, etc. and administrative matters related to the Department for Student Affairs provided for in the next paragraph.

5.2 Department for Student Affairs shall be placed within the UNIVERSITY to deal with administrative matters concerning academic affairs, student health and welfare guidance, etc.

5.3 Necessary matters concerning administrative organizations shall be provided for separately.

Article Six
(Affiliated Facilities)

6.1 The Research Center for Advanced Information Science and Technology, the Information Systems and Technology Center, the University-Business Innovation Center, the University of Aizu Revitalization and Creation Support Center, the Aizu Research Center for Space Informatics and other affiliated facilities shall be placed within the UNIVERSITY.

6.2 Necessary matters concerning affiliated facilities shall be provided for separately.

Article Seven
(Titles, Etc.)

7.1 The titles and respective duties of the internal organizations, etc, of the UNIVERSITY established in accordance with the provisions of Articles 3 through 6 above shall be in accordance with Appendix 1.

Chapter Three
Personnel Organization

Article Eight
(Responsibilities, Etc. of the Vice Chairperson and Regents of the Board of Executives)

8.1 The scope of responsibilities, concurrent positions and administrative duties of the Vice Chairperson and regents provided for in Article 9, Paragraphs 3 and 5 of the STATUTES shall be in accordance with the following.

Article Nine
(Return, Etc. of Regents to Educational Positions)

9.1 When Chairperson, Vice Chairperson or a regent wishing to return to the previous position as faculty at the CORPORATION, the CORPORATION may take measures to facilitate their returns to positions held prior to appointment. However, this excludes

cases in which the age of the individual concerned exceeds the official retirement age for faculty members.

9.2 The Vice Chairperson and regents, in cases where the Chairperson recognizes that it causes no hindrance to their primary employment duties, may engage in education, research or other duties recognized as being necessary to the minimum extent.

Article Ten

(Selection, Etc. of Executives)

10.1 The Vice Chairperson and regents shall be appointed by the Chairperson.

10.2 The term of office of the Vice Chairperson and regents shall be determined by the Chairperson and shall be no more than six years.

Article Eleven

(Executives' Remuneration, Etc.)

11.1 Necessary matters concerning executives' remuneration, retirement allowances, etc. shall be in accordance with the provisions of the Regulation Concerning Remuneration for Executives at the Public University Corporation, the University of Aizu and the Regulation Concerning Retirement Allowances for Executives at the Public University Corporation, the University of Aizu.

Article Twelve

(Titles and Types of Positions, Etc.)

12.1 Internal organizations, etc. of the CORPORATION listed in the left column of the following table shall be provided with the respective positions listed in the center column of that table, and the employment duties thereof shall be in accordance with the items listed in the right column of that table respectively.

Chapter Four Deliberative Institutions, Etc.

Article Thirteen (Board of Executives)

13.1 Based on the provisions of Article 14 of the STATUTES, the Board of Executives of the Public University Corporation, the University of Aizu (hereinafter referred to as the "BOARD OF EXECUTIVES"), comprising the Chairperson, the Vice-chairperson and regents shall be placed within the CORPORATION.

13.2 Necessary matters concerning the BOARD OF EXECUTIVES shall be in accordance with the provisions of the Regulation Concerning the Board of Executives of the Public University Corporation, the University of Aizu.

Article Fourteen (Management Council)

14.1 Based on the provisions of Article 17, Paragraph 1 of the STATUTES, the Management Council of the Public University Corporation, the University of Aizu

(hereinafter referred to as the “MANAGEMENT COUNCIL”) shall be placed within the CORPORATION to deliberate on important matters concerning management of the CORPORATION.

14.2 Necessary matters concerning the MANAGEMENT COUNCIL shall be in accordance with the provisions of the Regulation Concerning the Management Council of the Public University Corporation, the University of Aizu.

Article Fifteen
(Education and Research Council)

15.1 Based on the provisions of Article 18, Paragraph 1 of the STATUTES, the Education and Research Council of the Public University Corporation, the University of Aizu and the Education and Research Council of the Public University Corporation, the University of Aizu Junior College Division respectively (hereinafter referred to as the “EDUCATION AND RESEACRCH COUNCIL”) shall be placed within the University of Aizu and the University of Aizu Junior College Division to deliberate on important matters concerning education and research at the UNIVERSITY.

15.2 Necessary matters concerning the EDUCATION AND RESEACRCH COUNCIL shall be in accordance with the provisions of the Regulation Concerning the Education and Research Councils of the Public University Corporation, the University of Aizu and the Regulation Concerning the Education and Research Council of Public University Corporation, the University of Aizu Junior College Division.

Article Sixteen
(The University of Aizu Advisory Council)

16.1 The Advisory Council of the Public University Corporation, the University of Aizu (hereinafter referred to as the “ADVISORY COUNCIL”) shall be placed within the CORPORATION.

16.2 The ADVISORY COUNCIL shall deliberate on important matters concerning business operation of the CORPORATION in response to consultations from the Chairperson, and provide advice and recommendations to the Chairperson.

16.3 The ADVISORY COUNCIL shall comprise up to 15 advisors, who shall be appointed by the Chairperson from among individuals, other than personnel of the CORPORATION, with a broad knowledge and deep insight regarding university education.

Article Seventeen
(Faculty Assembly)

17.1 Based on the provisions of Article 93, Paragraph 1 of the School Education Law, the Faculty Assembly shall be placed within the School of Computer Science and Engineering and the University of Aizu Junior College Division respectively.

17.2 Necessary matters concerning the Faculty Assembly shall be in accordance with the provisions of the Regulation Concerning the Faculty Assembly of the University of Aizu and the Regulation Concerning the Faculty Assembly of the University of Aizu Junior College Division.

Article Eighteen
(Graduate School Faculty Assembly)

18.1 The Graduate School Faculty Assembly shall be placed within the Graduate School provided for in Article 4, Paragraph 2 above.

18.2 Necessary matters concerning the Graduate School Faculty Assembly shall be in accordance with the provisions of the Graduate School Regulation Concerning the Internal Administrative Organization and Other Aspects of the University of Aizu Graduate School of Computer Science and Engineering.

Article Nineteen
(Standing Committees)

19.1 Standing committees shall be placed as needed within the CORPORATION and the UNIVERSITY to deliberate on matters concerning business operation, education and research, etc.

Chapter Five
Financial Affairs and Accounting

Article Twenty
(Business Year)

20.1 The business year of the CORPORATION, in accordance with Article 32, Paragraph 1 of the Local Independent Administrative Agency Act (Law No. 118, 2003. Hereinafter referred to as the "LOCAL INDEPENDENT ACT"), shall begin on April 1 of each year and end on March 31 of the following year.

Article Twenty-One
(Financial Statements)

21.1 The CORPORATION, in accordance with the provisions of Article 34, Paragraph 4 of the LOCAL INDEPENDENT ACT, shall provide the Office of the CORPORATION with financial statements for each business year, and these shall be provided for public viewing during a period provided for in Article 11 of the Ruling Concerning the Fukushima Prefecture Public University Corporations (Fukushima Prefecture Ruling No. 54, 2006).

Article Twenty-Two
(Accounting Regulations)

22.1 Necessary matters concerning financial affairs and accounting at the CORPORATION shall be in accordance with the provisions of the Regulation Concerning Accounting Policies of the Public University Corporation, the University of Aizu.

Chapter Six

Internal Inspection and Evaluation, Etc.

Article Twenty-Three
(Internal Inspection and Evaluation)

23.1 The UNIVERSITY, in accordance with the provisions of Article 109, Paragraph 1 of the School Education Law (Law No. 26, 1947), in order to contribute to improvement of its level of education and research, shall inspect and evaluate the status of its education, research, etc., and make the results public.

Article Twenty-Four
(Certified Evaluation and Accreditation)

24.1 The UNIVERSITY, based on the provisions of Article 109, Paragraph 2 of the School Education Law (Law No. 26, 1947), shall undergo institutional evaluation for university accreditation by the Certified Evaluation and Accreditation Organization at intervals provided for in the Ordinance Concerning Implementation of the School Education Law (Ordinance No. 340, 1953) with regard to the overall status of the UNIVERSITY.

Article Twenty-Five
(Evaluation of Business Achievements)

25.1 The CORPORATION, in accordance with Articles 28 and 30 of the LOCAL INDEPENDENT ACT and Articles 6 of the Ruling Concerning Fukushima Prefecture Public University Corporations, must undergo evaluation by the Fukushima Prefecture Public University Corporation Evaluation Committee with regard to its business achievements for periods designated for mid-term goals.

Chapter Seven
Other Matters

Article Twenty-Six
(Publicizing of the Status Regarding Education and Research, Etc.)

26.1 The CORPORATION shall publicize the status regarding education and research, including the curriculums, and the status regarding its organization and operation, using a method that enables them to be widely known.

Article Twenty Seven
(Corporation Regulations)

27.1 CORPORATION regulations shall comprise regulations, rulings, rules, bylaws, outlines, guidelines, internal regulations and agreements.

27.2 Necessary matters concerning regulations shall be in accordance with the provisions of the Regulation Concerning the Regulations of the Public University Corporation, the University of Aizu.

Additional Provisions

This regulation shall be enforced as of April 1, 2006.

Additional Provisions

This regulation shall be enforced as of April 1, 2007.
