

Regulation Concerning the ADVISORY COUNCIL of the Public University Corporation,  
the University of Aizu

**Article One**

(Objective)

1.1 This regulation-based upon the provisions of Basic Regulation Concerning the Organization and Business Operation , Article 16-provides for necessary matters concerning the organization and administration of the University of Aizu Advisory Council (for the purpose of this ruling, hereinafter referred to as "ADVISORY COUNCIL").

**Article Two**

(Term Of Office)

2.1 The term of office of ADVISORY COUNCIL members shall be two years. However, the term of office of those members filling a vacancy shall be the remainder of the vacated term.

2.2 ADVISORY COUNCIL members may be reappointed.

**Article Three**

(Council Chairperson)

3.1 The position of Council Chairperson shall be established within the ADVISORY COUNCIL and shall be served by that member designated by the Governor.

3.2 The Council Chairperson shall provide general management of ADVISORY COUNCIL affairs and serve as the representative of the ADVISORY COUNCIL.

3.3 Should the Council Chairperson be unable to fulfill his/her duties, or should the position of Council Chairperson be vacant, the member previously designated by the Council Chairperson shall fulfill the Council Chairperson's duties on his/her behalf.

**Article Four**

(Meetings)

4.1 Meetings of the ADVISORY COUNCIL shall be convoked by the Council Chairperson.

4.2 The Council Chairperson shall serve as the chairperson of ADVISORY COUNCIL meetings.

4.3 ADVISORY COUNCIL meetings, if for which more than half of the members are not present, may not be convened.

4.4 Matters of business before the ADVISORY COUNCIL shall be decided by more

than half of those members in attendance; and when there is an equal number of members supporting both sides of an issue, the chairperson shall render the decision.

#### **Article Five**

(Requests For Explanations, Etc.)

5.1 The ADVISORY COUNCIL may request explanations, the expression of opinions, and the presentation of materials from personnel of the University of Aizu and the Junior College Division of the University of Aizu.

#### **Article Six**

(Miscellaneous Affairs)

6.1 Miscellaneous affairs of the ADVISORY COUNCIL shall be performed by the General Affairs and Budget Division of the University Division of the Administrative Office.

#### **Article Seven**

(Delegation Of Authority)

7.1 Other than provided for by this regulation, necessary matters concerning the administration of the ADVISORY COUNCIL shall be submitted by the Council Chairperson to the ADVISORY COUNCIL for deliberation and shall be decided.

#### **ADDITIONAL PROVISIONS**

1. This regulation shall be enforced as of April 1, 2006.
