University of Aizu Internal Quality Assurance Promotion Regulations (November 1st, 2025 Regulation No. 16)

(Purpose)

Article 1

The University of Aizu (including its Graduate School; hereinafter the same), in order to achieve the objectives prescribed in Article 1 of the Articles of Incorporation of the Public University Corporation, the University of Aizu, Article 1 of the University Regulations of the University of Aizu, and Article 4 of the Graduate School Regulations of the University of Aizu, shall, in accordance with the provisions of Article 109 of the School Education Act (Act No. 26 of 1947), regularly conduct self-inspection and evaluation of educational and research activities and other activities, verify the results, and link them to improvements. By establishing a system (hereinafter referred to as "Internal Quality Assurance") to continuously enhance the quality of educational and research activities of the University, the University shall strive to maintain and improve an appropriate level of its education and research.

(Policy on Internal Quality Assurance)

Article 2

The policy on internal quality assurance of the University of Aizu shall be separately determined by the President.

(Self-Inspection and Evaluation)

Article 3

- 1. Regarding the purpose stipulated in Article 1, self-inspection and evaluation shall be conducted based on the policy on internal quality assurance of the University of Aizu as defined in the preceding Article, in accordance with the policies indicated by the Planning and Management Committee, and the President shall instruct the Evaluation Committee to implement self-inspection and evaluation.
- 2. The implementation of self-inspection and evaluation shall be under the jurisdiction of the Evaluation Committee.
- 3. The Evaluation Committee, as necessary, shall present items and standards for self-inspection and evaluation to the heads of departments, etc., as stipulated in Article 3 of the Regulations on Internal Administrative Organizations of the University of Aizu (hereinafter referred to as "departments, etc."), and shall request each department, etc., to carry out self-inspection and evaluation.

(Implementation of Self-Inspection and Evaluation by Heads of Departments, etc.) Article 4

- 1. The heads of departments, etc., upon request as stipulated in paragraph 3 of the preceding Article, shall conduct self-inspection and evaluation in their respective departments, etc., and submit the results to the Evaluation Committee.
- 2. In implementing self-inspection and evaluation as stipulated in the preceding paragraph, the heads of departments, etc., shall cooperate with other related departments, etc., and the Administrative Office.

(Reporting of Self-Inspection and Evaluation Results)

Article 5

The Evaluation Committee shall compile the results of self-inspection and evaluation conducted in each department, etc., add items considered necessary for improvement, and report them to the President and the Planning and Management Committee.

(Requests to Heads of Departments, etc.)

Article 6

The President, upon receiving the report stipulated in the preceding Article, shall, through the Planning and Management Committee, request the heads of departments, etc., to take necessary measures.

Article 7

When requested to take measures pursuant to the preceding Article, the heads of departments, etc., shall report the results of such measures to the President and the Planning and Management Committee.

(Publication of Information)

Article 8

The President shall publish information related to internal quality assurance on the University's website.

(Miscellaneous Provisions)

Article 9

In addition to matters provided for in these Regulations, other necessary matters concerning the promotion of internal quality assurance shall be separately determined by the President.

Supplementary Provision

These Regulations shall come into effect as of November 1st, 2025.
