O Explanation on differences in amounts between budgets and amounts settled

- Note 1) With regard to grants, since front-loading of expenses for improvement of facilities was approved by the Fukushima Prefecture Government in its budget revisions in September, the amount settled was a 86,000,000 yen more than budgeted amount.
- With regard to self-income, due to a higher than expected income from tuition from enrolled Note 2) students and admission fees for students admitted in FY 2010, the amount settled was a 66,000,000 yen surplus.
- Note 3) With regard to revenue from external funds, the amount settled was a 5,000,000 yen surplus, as a result of increases in revenue from commissioned research.

With regard to operational expenses, postponment of the computer system contract renewal, differences in actual expenses and expense estimates regarding contracts for preparations for

- installment of equipment for the LML and CAI rooms, and other efforts made for cost economization, the amount settled for operational expenses was 233,000,000 yen less than the budgeted amount.
- Note 5) With regard to facilities expenses, the amount settled was 80,000,000 yen more than the relevant budgeted amount for the reason explained in Note 1) above.

Note 6) The amount settled for expenses for research to be conducted using external funds was 40,000,000 yen less than the relevant budgeted amount, due to a decrease in publicly-invited projects funds by the National Government
