2. Fundamental Objectives of the University

◆A Brief History of the University of Aizu

The University of Aizu was established in 1993 as the first university specializing solely in computer science in Japan. The University has focused on exploration of computer-related studies in both software and hardware at the School of Computer Science and Engineering (the Department of Computer Software and the Department of Computer Hardware) and at the Graduate School of Computer Science and Engineering, and has been dedicated to fostering of excellent researchers and technical experts who will be able to take an active role in the international community as well as in Japan.

The University of Aizu Junior College Division was established in 1951, as Aizu Junior College. The Junior College Division has directed its effort to fostering of human resources who will be capable of flexibly adjusting to industries in the age of information (Department of Industrial Information Sciences), fostering of food experts who have practical skills (Department of Food and Nutrition Sciences), and fostering of specialists in social welfare in a spirit of respect for humanity (Department of Social Welfare Sciences).

The University and the Junior College Division are the only institutions for higher education in the Aizu area.

Mission of the University of Aizu

Contribution to the advancement of science and technology as well as promotion of industry and culture, by fostering human resources and by conducting research in the fields of computer science and engineering, industrial information sciences, food and nutrition sciences, and social welfare sciences.

Fundamental Objectives of the University of Aizu

- (1) To foster researchers and technical experts who are rich in creativity and ethics and who will be able to play an active role in the global community, leaders of technological innovation, and human resources who have a spirit of entrepreneurship
