ADMISSION POLICY

The University of Aizu is the first university in Japan solely dedicated to computer science and engineering (CSE). Without question, CSE— encompassing information and communications technology (ICT) — has been a technological catalyst since the dawn of the digital age. Heralded as cutting-edge and with a bright outlook, CSE remains poised to bring about exciting new opportunities, and further unlock a new wealth of knowledge and applications with the potential to make the world more advanced and forward-looking than it is today. Founded on the principles "Act Locally, Think Globally" and "to Advance Knowledge for Humanity", since its beginning in 1993, the University of Aizu has conducted world-leading research and education in CSE, spearheaded by its own faculty comprised of highly accomplished researchers from all around the world. An ideal undergraduate student (incoming freshman) is one who can demonstrate mastery of basic academic skills, is ready to take on the intellectual challenges of college level coursework, is ready to study CSE fields with ease, and furthermore possesses either one or both of the following attributes:

- one who exhibits strong intellectual curiosity and passion, is ready to delve into the world of CSE, and recognizes the hallmark of the University of Aizu's unique undergraduate program well enough to list the University of Aizu as their first-choice school.
- one who aspires to make a difference to the world through applying their ICT knowledge and skills.

In the same vein, the University of Aizu has set the following basic admission selection policy.

Basic Admission Selection Policy

The University of Aizu administers a written exam as the means of identifying academically meritorious applicants who possess fundamental skills specifically in mathematics and English.

3. Application Eligibility

The following individuals are eligible.

- (1) Individuals who have completed or are expected to complete by September 30, 2025 a 12-year school education curriculum outside of Japan (If the curriculum is less than 12 years in length, an additional course of study must be completed at a designated preparatory course or training facility.)
- (2) Individuals who have completed or are expected to complete by September 30, 2025 the curriculum of a designated school in a foreign country corresponding to a Japanese high school that meets requirements such as being considered equivalent to the completion of a curriculum of 11 years or more in length
- (3) Individuals who have graduated from a senior high school or a secondary education school in Japan, or those who are expected to graduate from one by September 30, 2025
- (4) Individuals who have completed or are expected to complete by September 30, 2025 a special education school high school or the third year of a technical college in Japan
- (5) Individuals who have completed or are expected to complete by September 30, 2025 the curriculum of a foreign school in Japan that has been designated as equivalent to that of a high school in a foreign country (If the curriculum is less than 12 years in length, an additional course of study must be completed at a designated preparatory course.)
- (6) Individuals who have completed or are expected to complete by September 30, 2025 a program at an overseas educational institution accredited by the Minister of Education, Culture, Sports, Science and Technology (MEXT) as equivalent to a high school
- (7) Individuals who have completed on or after the date designated by the Minister of MEXT or are expected to complete by September 30, 2025 an upper secondary curriculum at a

- Japanese specialized training college designated separately by the Minister of MEXT
- (8) Individuals who passed the Japan's Upper Secondary School Equivalency Examination (previously the University Entrance Qualification Examination)
 - (If the applicant has not yet reached 18 years of age, they shall only be eligible for university admission on the day after reaching 18 years of age.)
- (9) Individuals other than those listed above who will be at least 18 years of age by September 30, 2025 and who are recognized by the University, based on Pre-application Review, as having academic abilities equal or superior to individuals who have graduated from a senior high school

Applications will not be accepted if the pre-screening documents are not submitted by the deadline.

4. Application Requirements

The applicant must fulfill the following requirements (1) and (2).

- (1) The applicant must submit proof of test results for one of the following English proficiency tests:
 - TOEFL (iBT) Target score 72+ (Designated Institution Code: C624)
 - · TOEIC (L&R) Target score 785+
 - EIKEN Target Grade Pre-1 or above
 - IELTS Target score 5.5+

Tests must be taken no more than two years before the application deadline.

The following English proficiency tests are not accepted:

- · TOEFL (iBT) Home Edition
- · IELTS Indicator

However, if for some reason you are unable to take any of the above English proficiency tests, contact the University of Aizu via e-mail.

Further, if you have received at least three years of upper secondary education in English, you may submit a certificate to that effect received from the school's principal in lieu of proof of test results for the above English proficiency tests.

(2) The applicant must submit official results that meet the grade requirements for each of the designated subjects in one of the examinations listed in the Appendix on page10-11. Applicants unable to submit the final scores/grades by the application deadline must submit a certificate of official predicted scores/grades issued by their school. If the applicant's final scores/grades do not meet the grade requirements listed in the Appendix, the applicant will be considered ineligible. In this case, a final result of "Pass" will be revoked after the applicant's final scores/grades are confirmed. Also, if the applicant is unable to submit the final scores/grades by enrollment date, a final result of "Pass" will be revoked. In either case, all paid fees including the application fee and admission fee will not be refunded.

5. Selection Process

Selection shall be a comprehensive process based on submitted application documents. Please note that applicants may be required to answer questions via email or attend an online interview.

7. Application Procedures

(1) How to Apply

- a. Convert application documents 1-8 on pages 4-5 to PDF files and email them to sguadmission@u-aizu.ac.jp. Do not open sealed documents. Instead, send a scan of both sides of the envelope. The deadline for submitting PDFs is one week before the application deadline.
- b. After submitting your application documents, pay the application fee when instructed to do so by the University.
- c. The original copies of application documents 1-9 must arrive by the application deadline.

Application documents must be sent by post (applicants residing in Japan must use registered express mail, while overseas applicants must use air mail), or be handed to the University of Aizu in person. If submitting the application documents in person at the University of Aizu, please visit the Student Recruiting Section of the Student Affairs Division between 9:00 a.m. and 5:00 p.m. on a weekday (excluding holidays).

(2) Application Period

Please refer to the Application Period under "1. Application Process" on page 1. Applications must arrive by the deadline listed there. Note too that the closing time is shown in Japan Standard Time. If the documents cannot be sent to the University of Aizu by the deadline due to unavoidable circumstances, contact us before the deadline and follow the instructions you are given.

Submit the original copies of all application documents. If you are unable to submit the original copy of a document, send a certified copy issued by your former (current) school, testing agency, or a notary public office. <u>Submitted application documents will not be</u> returned for any reason once accepted.

Please fill out clearly all the forms in English or in Japanese. If the application documents and other documents are in any other language, unseal them and submit them with a translation affixed with the seal of approval of your school, an embassy, a notary public office,

or a government-approved institution (applicants may prepare the translation.). Please translate documents in any other languages. Do not staple the documents.

8. Announcement of Successful Applicants

(2) Additional Acceptances

Vacancies caused by successful applicants declining enrollment may be filled by additional acceptances.

Additionally-accepted applicants will be notified by email beginning on June 16, 2025.

We DO NOT respond to any inquiries on this matter. Additionally-accepted applicants will be notified of enrollment procedures along with their notification of acceptances.

(3) Revocation of Acceptance

Acceptance will be revoked in the following cases:

- a. Applicants do not submit proof of graduation by the date of admission.
- b. Applicants accepted based on a certificate of expected scores/grades do not submit the final grades.
- c. The final scores/grades of applicants applied using a certificate of expected scores/grades do not meet the application requirements.
- d. Applicants are not granted a Certificate of Eligibility.
- (4) No inquiries regarding the reasons for acceptance or rejection will be answered.

9. Enrollment

(1) Enrollment Procedures

- a. The documents, etc. necessary for admission procedure will be emailed to successful applicants after announcement of successful applicants.

11. Points to Note

- (1) Incomplete applications and applications that arrive after the deadline will not be considered.
- (2) Please note that once accepted, neither the application documents nor the application fee will be returned for any reason.
- (3) Changes to the content of submitted application documents are not allowed.
- (4) If any false statements are found in the application documents, admission will be revoked even after the applicant's admission has been approved.
- (5) If acceptance is revoked, admission will be canceled even after the admission letter has been issued.
- (6) Even in cases of (4) and (5) above, application documents, the application fee, and the admission fee will not be returned.
- (7) Applicants with disabilities who may require special measures for the purpose of taking exams or special considerations in carrying out their studies must submit a request for consultation (no set format) containing the following items, along with their application documents in Japanese or English.
 - a. The name and address of the applicant (please include a telephone number where you can be contacted as well)
 - b. The name of the applicant's school
 - c. The type and degree of the disability (individuals currently being treated for the condition must attach a doctor's written statement of diagnosis)

- d. Any special measures that applicant would like to request that may facilitate the applicant to take exams
- e. Any matters requiring special consideration to help the applicant to carry out his/her studies
- f. Any special measures that had been provided by the applicant's school
- g. The situation regarding the applicant's daily life

Further, when submitting the item c in a language other than Japanese or English, please submit a translation. Translations, which can also be made by the applicant, must be accompanied by a seal of approval from your school, an embassy, a public notary, or a government-approved institution.

12. Others

(1) Immigration and Visa Procedures

All immigration and residence procedures required to enroll in the University of Aizu must be completed before admission. The applicant is entirely liable if he or she is unable to actually be admitted to the University as a result of failing to complete the immigration and other procedures. In such cases, submitted documents, payments made, etc. will not be returned.

Proof of admission is sometimes required in order to acquire a student visa. However, please note that proof of admission at the University of Aizu can only be provided after admission fees are paid and admission procedures are completed. Please confirm with your embassy ahead of time regarding the acquisition of student visas.

(2) Scholarships

Scholarship, etc. are available from the Independent Administrative Institution Japan Student Services Organization (JASSO). Details will be provided at a briefing session after admission.

(3) Housing

The University of Aizu has on-campus housing in the form of Somei House, a dormitory aimed at supporting students' studies. Residency in Somei House is selective. Besides Somei House, there are boarding houses, apartments, etc. targeted at students available around the city. For more information, visit the University of Aizu homepage.
