#### ADMISSION POLICY

The University of Aizu is the first university in Japan solely dedicated to computer science and engineering (CSE). Without question, CSE— encompassing information and communications technology (ICT) — has been a technological catalyst since the dawn of the digital age. Heralded as cutting-edge and with a bright outlook, CSE remains poised to bring about exciting new opportunities, and further unlock a new wealth of knowledge and applications with the potential to make the world more advanced and forward-looking than it is today. Founded on the principles "Act Locally, Think Globally" and "to Advance Knowledge for Humanity", since its beginning in 1993, the University of Aizu has conducted world-leading research and education in CSE, spearheaded by its own faculty comprised of highly accomplished researchers from all around the world. - one who aspires to make a difference to the world through applying their ICT knowledge and skills.

In the same vein, the University of Aizu has set the following basic admission selection policy.:

#### **Basic Admission Selection Policy**

The University of Aizu administers a written exam as the means of identifying academically meritorious applicants who possess fundamental skills specifically in mathematics and English.

# 3. Application Eligibility

The following individuals shall be eligible.

- Individuals who have completed or are expected to complete by September 30, 2026 a 12year school education curriculum outside of Japan (If the curriculum is less than 12 years in length, an additional course of study must be completed at <u>a designated preparatory</u> <u>course</u>\*1 or <u>training facility</u>\*2.)
- (2) Individuals who have completed or are expected to complete by September 30, 2026 the curriculum\*<sup>3</sup> of a designated school in a foreign country corresponding to a Japanese senior high school that meets requirements such as being considered equivalent to the completion of a curriculum of 11 years or more in length
- (3) Individuals who have graduated from or are expected to graduate from a senior high school or secondary education school in Japan by September 30, 2026
- (4) Individuals who have completed or are expected to complete by September 30, 2026 an upper secondary education at a special needs school or the third year of a technical college in Japan
- (5) Individuals who have completed or are expected to complete by September 30, 2026 the curriculum of a foreign school<sup>\*4</sup> in Japan that has been designated as equivalent to that of a senior high school in a foreign country (If the curriculum is less than 12 years in length,

an additional course of study must be completed at <u>a designated preparatory course</u>\*1.)

- (6) Individuals who have completed a 12-year curriculum of educational institutions accredited by international accrediting bodies (Western Association of Schools and Colleges (WASC), Association of Christian Schools International (ACSI), Council of International Schools (CIS), New England Association of Schools and Colleges (NEASC), Cognia International Schools (COBIS))
- (7) Individuals who have completed or are expected to complete by September 30, 2026 <u>a</u> curriculum at an overseas educational institution designated by the Minister of Education, <u>Culture, Sports, Science and Technology (MEXT) as equivalent to a senior high school</u>\*<sup>5</sup>
- (8) Individuals who have completed on or after the date designated by the Minister of MEXT or are expected to complete by September 30, 2026 an upper secondary curriculum at a Japanese specialized training college designated separately by the Minister of MEXT
- (9) Individuals who passed the Japan's Upper Secondary School Equivalency Examination (previously the University Entrance Qualification Examination)
  (If the applicant has not yet reached 18 years of age, they shall only be eligible for university admission on the day after reaching 18 years of age.)
- (10) Individuals other than those listed above who will be at least 18 years of age by September 30, 2026 and who are recognized by the University based on Review of Eligibility as having academic abilities equal or superior to individuals who have graduated from a senior high school

#### 4. Application Requirements

The applicant must fulfill the following requirements (1) and (2).

- (1) The applicant must submit proof of test results for one of the following English proficiency tests:
  - TOEFL (iBT) Target score 72+
  - TOEIC (L&R) Target score 785+
  - EIKEN Target Grade Pre-1 or above
  - IELTS Target score 5.5+

Tests must be taken no more than two years before the application deadline.

The following English proficiency tests are not accepted:

- TOEFL (iBT) Home Edition
- IELTS Indicator
- (2) Official Examination Results for Academic Ability (Standardized Examinations):
  - The applicant must submit official results that meet the grade requirements for each of the designated subjects in one of the examinations listed below. Applicants unable to submit the final scores/grades by the application deadline must submit a certificate of official predicted scores/grades issued by their school. If the applicant's final scores/grades do not meet the grade requirements listed below, the applicant will be considered ineligible. In this case, a final result of "Pass" will be revoked after the applicant's final scores/grades are confirmed. Also, if the applicant is unable to submit the final scores/grades by enrollment date, a final result of "Pass" will be revoked. In either case, all paid fees including the application fee and admission fee will not be refunded.

#### 7. Application Procedures

- (1) How to Apply
  - a. Convert application documents 1-9 on pages 6-7 to PDF files and email them to sguadmission@u-aizu.ac.jp. The subject title should be "ICTG AY2026 Application Documents". Emails with different subject titles may not be accepted. Do not open sealed documents. Instead, send a scan of both sides of the envelope.
  - b. After submitting your application documents, pay the application fee when instructed to do so by the University.
  - c. The original copies of application documents 1-10 must arrive by the application deadline. The original copies of application documents must be sent by post (applicants residing in Japan must use registered express mail (書留速達: kakitome sokutatsu), while overseas applicants must use air mail), or be handed to the University of Aizu in person. If submitting the application documents in person at the University of Aizu, please visit the Student Recruiting Section of the Student Affairs Division between 9:00 a.m. and 5:00 p.m. on a weekday (excluding holidays).
  - After the application period, an applicant number will be sent to the e-mail address indicated on Application Form 1. If you have not received your applicant number after April 15, please contact us.

#### (2) Application Period

Note too that the deadline is shown in Japan Standard Time (JST). #### (4) Application Documents

Submit the original copies of all application documents. If you are unable to submit the original copy of a document, send a certified copy issued by your former (current) school, testing agency, or a notary public office. <u>Submitted application documents will not be</u> <u>returned for any reason.</u>

These certificates and certified copies should be in either English or Japanese. If they are in any other language, unseal them and submit them with a translation affixed with the seal of approval of your school, an embassy, a notary public office, or a government-approved institution (applicants may prepare the translation). Do not staple the documents.

Vacancies caused by successful applicants declining enrollment may be filled by additional acceptances.

Additionally-accepted applicants will be notified by email beginning on June 15, 2026.

(3) Revocation of Acceptance

Acceptance will be revoked in the following cases:

- a. The applicant do not submit proof of graduation by the date of enrollment.
- b. The applicant accepted based on a certificate of expected scores/grades does not submit the final grades.
- c. The final scores/grades of the applicant who applied using a certificate of expected scores/grades do not meet the application requirements.
- d. (Applicants without Japanese citizenship, etc.) The applicant is not granted a Certificate of Eligibility.
- (4) We do not respond to inquiries regarding the reasons for acceptance or rejection.

# 11. Points to Note

- (1) Incomplete applications and applications that arrive after the deadline will not be considered.
- (2) Please note that once accepted, neither the application documents nor the application fee will be returned for any reason.
- (3) Changes to the content of submitted application documents are not allowed.
- (4) If any false statements are found in the application documents, admission will be revoked even after the applicant's admission has been approved.
- (5) If acceptance is revoked, admission will be canceled even after the admission letter has been issued.
- (6) Even in cases of (4) and (5) above, application documents, the application fee, and the admission fee will not be returned.
- (7) Applicants with disabilities who may require special arrangements for the purpose of taking

exams or special considerations in carrying out their studies must submit a request for consultation (no set format) containing the following items, along with their application documents in Japanese or English.

- a. The name and address of the applicant (please also include a telephone number where they can be reached)
- b. The name of the applicant's school
- c. The type and degree of the disability (individuals currently being treated for the condition must attach a doctor's written statement of diagnosis)
- d. Any special arrangements that applicant would like to request that may facilitate the applicant to take exams
- e. Any matters requiring special consideration to help the applicant to carry out their studies
- f. Any special arrangements that had been provided by the applicant's school
- g. The situation regarding the applicant's daily life

Further, when submitting item c in a language other than Japanese or English, please submit a translation. Translations, which can also be made by the applicant, must be accompanied by a seal of approval from your school, an embassy, a notary public office, or a government-approved institution.

#### 12. Others

(1) Immigration and Visa Procedures

All immigration and residence procedures required to enroll in the University of Aizu must be completed before admission. The University shall not be held liable in the event the applicant is unable to actually be admitted to the University as a result of their failure to complete the immigration and other procedures. In such cases, documents submitted, payments made, etc. will not be returned.

Proof of admission is sometimes required in order to acquire a student visa. However, please note that proof of admission at the University of Aizu can only be provided after admission fees are paid and admission procedures are completed. Please confirm with your embassy ahead of time regarding the acquisition of student visas.

(2) Scholarships

Scholarship and other financial aid are available from the Independent Administrative Institution Japan Student Services Organization (JASSO). Details will be provided after admission.

(3) Housing

The University of Aizu has on-campus housing in the form of Somei House, a dormitory aimed at supporting students' studies. Residency in Somei House is selective. Besides Somei House, there are boarding houses, apartments and other housing targeted at students available around the city. #### 13. Handling of Personal Information

Personal information is handled in accordance with the Act on the Protection of Personal Information and the Regulation on the Protection, Etc. of Personal Information Handled by The Public University Corporation, the University of Aizu.

- (2) Examination results used for selection of applicants may be used for the purpose of postadmission education and instruction, as well as the creation of materials for the consideration of future selection methods.
- (3) Personal information obtained through application procedures and the examination results used for selection of applicants may be used, to the extent they relate to admitted students, for the purpose of 1) academic affairs (learning support, etc.), 2) student support (registration, health management, career support, tuition exemption/scholarship application, dorm residency selection), and 3) tasks related to the collection of tuition.
